TERMS OF REFERENCE

Phnom Srey Association for Development (PSAD) Project Final Evaluation of Pro-Poor Initiatives for Livelihood Improvement (PILI) 2008-2010

1. Back ground

Phnom Srey Association for Development (PSAD) is a local non-governmental and non-profit organization. PSAD was established since November 1998, in partnership with the Royal Government of Cambodia, aimed to contribute to the development of Cambodia. This organization was registered with the Council of Ministers in January 1999 and with the Ministry of Interior in October 2000. It has a head office in Kampong Cham town, Cambodia.

PSAD is implementing many projects in the essential departments such as Integrated Community Development Department, Advocacy, Net working and Partnership Department and Health department which in these departments have many projects to achieve its strategic plan. Pro-Poor Initiatives for Livelihood Improvement (PILI) is one of the projects that have been implementing by PSAD and sponsored by Concern World Wide Cambodia since 2006. The table below shows a number of current projects under PSAD's implementation.

The project for final project evaluation is PILI project under Concern's funding support. PSAD has been implementing this project in 20 villages, 11 communes and 3target districts in Kampong Cham province with 1,365 poor/poorest beneficiaries including 1,027 females. It focuses especially on vulnerable people and poor/poorest families in order to generate more income to improve the people's livelihoods in a sustainable manner through natural resource management (NRM) and agriculture farming. Otherwise we also have a good collaboration with various specialized provincial departments, Agriculture Department, Provincial Fisheries Administration Department...etc and other NGOs both inside and outside Kampong Cham province.

2. Objectives of Evaluation

There are three main objectives for this evaluation of PSAD as the following:

- > To measure the impacts and progress of the project implementation of PSAD against the indicators of the project goal, objective and outputs in the logical framework;
- > To identify strengths, weaknesses, lessons learned and good practices of the project and organizational management of PSAD and recommend appropriate strategies for improvement;
- ➤ To assess major challenges, constraints encountered and opportunities during project implementation of PSAD and recommend appropriate strategies for future project design towards improving livelihoods of the poorest living in rural communities.

3. Outputs of Evaluation

The outputs of the evaluation include:

- ➤ Documented progress, impacts and good practices of the project of PSAD;
- > Documented strengths, weaknesses and lessons learned of the project and organizational management of PSAD;
- ➤ Identified challenges, constraints and opportunities of the project with appropriate strategies for effectiveness of livelihood improvement of the poorest;
- > Written report highlighting the findings and recommendations for future project design.

4. Scope of Work/Role and Responsibility

Roles and responsibilities of evaluator

- Identify appropriate methods for evaluation and outlines of the evaluation report with common agreement between PSAD and evaluator
- Become familiar with PSAD background, approaches of project implementation and logical framework
- Review all relevant documents through reading and discussions with PSAD project staff
- Develop action plan with PSAD staff before implementation of evaluation and conduct evaluation based on developed action plan
- Day to day management and implementation of evaluation
- Use participatory approach that encourages discussion of the findings and ownership of the conclusion and recommendations by all the primary stakeholders
- Finalize the findings, and provide report in English and Khmer to PSAD
- Facilitate meeting to discuss preliminary findings, and also discuss on draft final report with PSAD staff
- Consult with PSAD and Concern about process of evaluation
- Arrange themselves the transportation and accommodations from Phnom Penh or other provinces to Kampong Cham during the evaluation
- Submitting evaluation report both in Khmer and English
- Make sure that the finding of evaluation meets the objectives and outcomes of evaluation

Roles and responsibilities of PSAD

- Prepare logistics for evaluation process; budget planning, materials needed for evaluation
- Draft ToR and discuss it with the management team of PSAD
- Coordinate with evaluator to develop action plan for evaluation
- Arrange transportation for traveling to the field for evaluator
- Organize meeting/workshop with relevant stakeholders and organize the meeting with community groups/project participants
- Participate in the meeting with evaluation team
- Advertise the evaluation on newspaper and other media
- Conduct recruitment process for evaluation team and select the evaluation team
- Keep Concern and Board of Directors of PSAD informed about the progress and schedule of the project evaluation
- Make sure that the first draft report will be circulated to its Board of Directors and Concern for comments or feedback, and a copy (both soft and hard copy) of final evaluation report will be submitted to Concern.
